**Bus Fencing Project**

Superintendent Watson presented the bid for the bus fencing at the Board of Education Building. The bid was from Triple E Fencing for \$15,300. Walter Wytch made a motion to accept this bid and Amy Dugger seconded the motion.

**Heritage Room Curator**

Superintendent Watson made a recommendation to appoint Sue Bass Wilson Curator for the Heritage Room at the Andalusia High School. Walter Wytch made a motion to approve this recommendation and Tommy Wright seconded the motion.

**Next Meeting**


