Each local school should utilize the information in this guidance document to create their own individualized re-entry plan to share with stakeholders. This information follows the Guidance for K-12 School Operations for In-Person Learning developed by the Kentucky Department of Public Health. Information is subject to change as we continue to receive updated information from the Department of Public Health, Kentucky Department of Education, Kentucky Governor's Office, and the Centers for Disease Control and Prevention.  <a href="#">Guidance document gone through and there are no mandates at this time only recommendations.</a>

		<p>Below is a rough draft of the Re-Entry Plan updates from last year. Waiting for input from all stakeholders:</p> <ul style="list-style-type: none"> <li>● Added vaccine promotion box; vaccine proof info;</li> <li>● Updated cleaning box to DPH statement - “once a day enough, consider high-touch shared surfaces more frequently”</li> <li>● Removed process of cleaning dirty linens;</li> <li>● Hand hygiene box - added word visitors with staff and students;</li> <li>● Removed box stating to establish a system for drop off and pick up that keeps families physically distant from each other; Each school has its own procedure for drop off and pickup.</li> <li>● Removed box stating to limit visitors except for required essential services - this is now part of the contingency plan. Parents are now allowed into the building.</li> <li>● Removed box stating to restrict school sponsored travel - this is now part of the contingency plan.</li> <li>● Updated box related to physical distancing - tape no longer required on floors/sidewalks; Updated to maintain at least 3-6 feet distance, if able;</li> <li>● Updated box related to cross-training staff members - added each school should have a coverage plan.</li> <li>● COVID screening procedures - Parental assurance form updated - no longer require signature from parent - send home as handout. Staff assurance form also updated;</li> <li>● Box related to masks - masks are optional for staff/students - this includes school buses; Full time mask use added to contingency plan; Students will still report directly to class room upon arrival to school;</li> <li>● Removed box related to a referral process for school entry for students - this will be a continuation of services - each school already works with parents/students regarding their needs.</li> <li>● Removed box stating lockers can not be used;</li> <li>● Added contingency plan at bottom of document;</li> <li>● Waiting on update from KDE about mass screenings - CCHD states not recommended at this time; KDE states to continue - will speak to them about audit purposes;</li> </ul>
