CALLED MEETING

JULY 30, 2013

MINUTES

The called meeting of the Sumter County Board of Education was called to order by Edith Ann Green, Chairman with the following other members present: Willa Fitzpatrick, Michael Busman, Alice Green, Meda Krenson, and Michael Lewis.

A moment of silence was observed.

The agenda was unanimously approved on a motion made by Mrs. Fitzpatrick; second by Ms. Alice Green. Mr. Lewis entered the meeting after the vote.

A motion was made by Mrs. Krenson; second by Ms. Alice Green to set the gross millage rate at 17.533 for 2013; motion carried unanimously.

A motion was made at 6:09 p.m. by Mr. Lewis; second by Mrs. Fitzpatrick, to go into executive session to review an appeal from a Student Disciplinary Tribunal; motion carried unanimously.
