2020-2021 Online Registration & ParentVue

We are excited to announce that in the Fall of 2020 we will start using an online registration process! This will help to eliminate a lot of paperwork we ask parents to fill out during registration. We will still have some hard copies of items we will need you to sign at the elementary level, but we hope this transition will make the registration process much faster!

In order to register your child online, parents will need to sign up for a "ParentVue" account. If you have older children (middle or high school age) you most likely already have a ParentVue account to check your students grades, attendance and other school records. In this case you will NOT need to create another one.

Last week you should have received an email with directions on how to sign-up for a ParentVue account. If you did not receive one or have any questions, please do not hesitate to call our school offices & our secretaries will be happy to help you out!

The registration process for 2020-2021 will begin in August, but we are hoping to get parents signed up now so that everyone is ready!

Map & Directions for End of Year Celebration Activities!

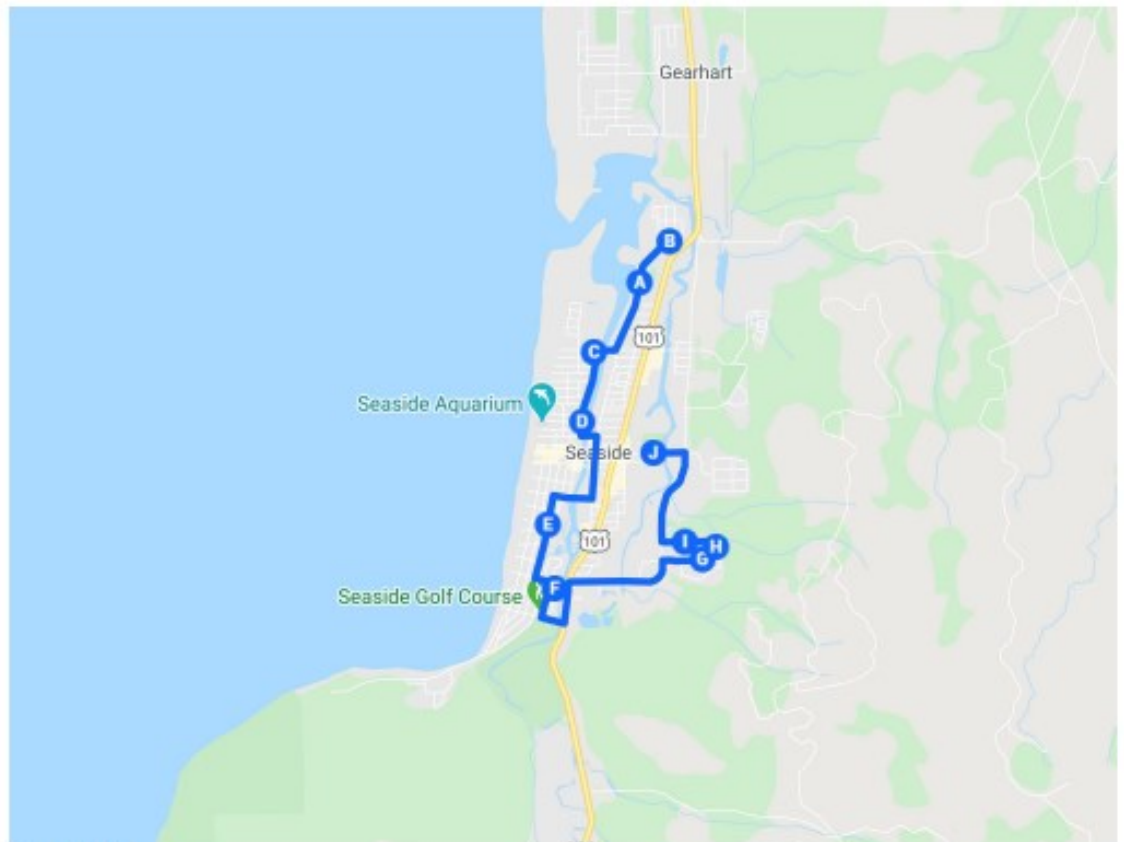

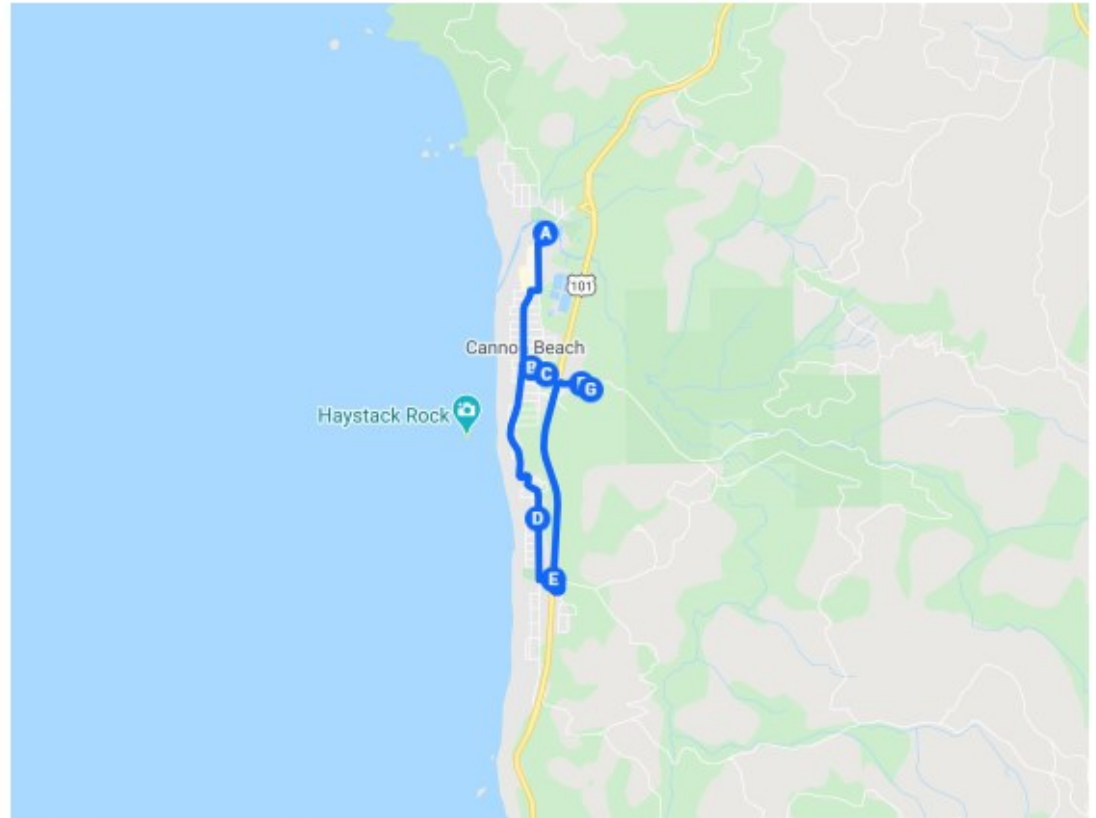

This summer, children can enjoy lunches at no charge through the Summer Food Service Program, a federally funded nutrition program open to all kids aged 1-18 years. No applications are necessary to drop in and all children and teens are welcome. The Summer Food Service Program makes sure all children can eat healthy food during the summer months when they cannot eat at school.

USDA has granted a waiver to the Oregon Department of Education so the Seaside School District can provide a grab-n-go meal service (breakfast and lunch) due to the COVID-19 pandemic. Meals are served at a designated site and children and/or an authorized adult may pick up meals for consumption off site. **Only one grab-n-go meal is allowable per child; however, an authorized adult may request additional meals for children that were unable to come to the delivery location.**

Reminder Notice

May 2020

The Seaside School District is continuing to support your child during this COVID-19 crisis. We hope the information below about accessing food will be a benefit to you.

- Oregon is the recipient of a grant to provide funds to children experiencing food insecurity due to COVID-19. The Department of Human Services and Oregon Department of Education Child Nutrition have requested that the Seaside School District provide information that would allow our students to participate in the Pandemic School Meal Replacement Benefits. Seaside is eligible even though our students continue to receive meals from their school since closure in March. Simply because the School District participates in the federal meal program, "benefits equivalent to one free lunch and one free breakfast for each eligible child – \$5.70 per normal school day for the months of March, April, May, and June." The program is optional and is supported through the Oregon Trail Card (EBT) system.
- The EBT system is used to provide funds to ALL eligible students. Existing Oregon Trail Card beneficiaries will have additional funds added to their cards. Families who do not already have a card will receive one with a letter explaining the program. This is an opt-in program, requiring activation of the Oregon Trail card. Families who do not wish to participate may destroy the cards. Any funds not used are returned.
- If your students in grades 6 – 12 and are currently eligible to receive free or reduced-price school meals, they are eligible. If your student is kindergarten – grade 5, they are eligible regardless of income because we are operating in a program that offers free meals to all elementary students.
- There is nothing that you have to do. We just want our families to be aware that their student(s) may qualify for the Pandemic School Meal Replacement Benefits and that you may be receiving additional information from other State agencies. Please understand that the School District is providing eligibility information; however, we are not in charge of administering this program.
