Regular Monthly Meeting
Minutes

On Monday, June 18, 2018 at 4:30 p.m., the Randolph County Board of Education met for their regular monthly scheduled meeting in the Central Services Board Room at the 2222-C S. Fayetteville Street Office in Asheboro. Board Members in attendance: Gary Cook (Chairman), Tracy Boyles (Vice-Chair), Brian Biggs, Sharon P. Farlow, and Matthew Lambeth. Superintendent Stephen Gainey, Leadership Team, and Attorney Jill Wilson also were present at the meeting.

Open Session

Call to Order

Chairman Cook called the meeting to order at 4:30 p.m.
