### 9. PUBLIC - AGENDA/NON-AGENDA ITEMS

This is the time when anyone from the public who wishes to speak to the Board may do so. Please state your name, address, and phone number. The Board will hear your concerns. The Board may or may not take action this evening. You will be notified either at this meeting, by letter, or telephone of any action the Board does take.

Scott Campbell, Business Administrator, updated Board Members and the audience on budget items and the status of the election. Mr. Campbell reported that it has been disclosed that all districts can look forward to having their Distance Learning Aid eliminated and state aid cut due to the constraints the state is currently under. He reported that state aid figures might not be available until April 1, 2002. This in turn would force the budget approval by the Board, advertising the budget, the budget hearing and the elections all to be pushed back. It has been discussed that the elections may be pushed back to the second Tuesday in May.

Scott Campbell then read the results of the recent Greenwich Township Board of

Education Foreign Language Interest Survey. The results are as follows:

Number of surveys sent to the public: 2,150

Number of respondents: 195 or 9.07%

Breakdown by language:

Italian132 or 67.7%No language added30 or 15.4%Spanish13 or 6.7%

French 11 or 5.6%

Latin 5 or 2.6% German 3 or 1.5% Sign Language 1 or .5%

Joseph Marcucci, Board President, read a prepared statement:

"At this juncture, the Board feels it has exhausted the answering of all questions concerning the initiation of Italian within our curriculum for the 2002-2003 school year. Until the budget process is massaged and finalized, no decision can and will be made concerning the institution of Italian as a language within our district for the 2002-2003 school year. We have yet to hear from the state and county superintendent's office concerning our aid allocation for the coming year. The Board has no further comment on this issue until the above information is received."

Joe Duca, 219 Cucinotta Drive, Gibbstown, NJ, wanted to know if the vacant Spanish position was filled.

Superintendent Combs responded that some of the applicants have taken jobs elsewhere and that there is a small pool of certified individuals that we have to choose from and that he hoped that he would have a final answer for the February meeting.

John Fabiani, 20 Holly Place, Gibbstown, NJ, asked what would make up the Italian curriculum?

Superintendent Combs answered that the course would consist of conversation in the dialect, review of the culture and history and that the course would evolve from that point.

Lou Fabiani, 21 Oak Street, Gibbstown, NJ asked if the Comprehensive Annual Finance Report is available to the public.

Joseph Marcucci responded that it was available to the public.

Lou Fabiani then asked if money available from investments that the Board makes could be used to support new programs and could we pull from surplus available.

Scott Campbell answered that current state law requires that unreserved general fund balance or surplus that is in excess of the established statutory limitation has to be appropriated back into the budget to relieve the tax burden on the public.

This year the district was required to place \$497,000 back into the budget to give the citizens of the township some tax relief. The increase for this year was 2.9 cents and it would have been over 11 cents if this money were not placed back as required.

Frank Boultinghouse, 228 Marshall Avenue, Gibbstown, NJ, asked if an advertisement has been placed in the paper for the vacant language position.

Joseph Marcucci answered that an ad for a Spanish Teacher with additional experience in Italian has been placed in the Philadelphia Inquirer.

Chuck Tortella, 414 Swedesboro Road, Gibbstown, NJ, asked whose job it is to apply for grants.

Joseph Marcucci answered that the superintendent will make recommendations to the Board they will in turn approve or disapprove the submittal of the grant.

Mr. Tortella then asked who authorized the superintendent to submit the application for the Italian language grant.

Joseph Marcucci answered that no one gave the superintendent approval to apply for the funds.
